UNIVERSITY PROFILE

Established by the State Legislature Act 28 of 2014 on July 24, 2014, CSRU has a sprawling campus of 75 acres situated 2 kilometres from Gohana Bypass, Jind. The university was established with the vision of imparting quality education by creating most conducive ambience for the production and dissemination of knowledge guided by innovative thinking, scientific enquiry, sublime human values, sustainable ecology, and democratic ethos. The aim of the University is the cultivation of citizens with a rich awareness of our heritage to lead and serve in every sphere of human activity. Working under the leadership of eminent educationists and social reformers, Hon'ble Chancellor Prof. Kaptan Singh Solanki and dedicated, dynamic and devoted personality Vice- Chancellor Prof. R.B. Solanki, the University is heading towards realization of its vision and the goal of being in the world ranking by 2020.

The University is affiliated u/s 2(f) and 12 (B) of the UGC Act, 1956 vide letter no. 9-12/2014(CPP-I/PU) dated 26 September, 2014 and is also a member of the Association of Indian Universities. In a short span of four years, the university has many achievements to its credit. The First Convocation of the University was held on April 18, 2017. Prof. Kaptan Singh Solanki, Governor of Haryana was the Chief Guest and delivered the Convocation Address. Ch. Birender Singh, Steel Minister, Government of India, Sh. Ramesh Kaushik, Member of Parliament, Smt. Prem Lata, MLA and Sh. Jasbir Deswal, MLA were also graced the convocation as Guests of Honour. The university gave 14 Gold Medals, 13 M.Phil, 289 Post Graduates and 289 Under Graduates Degrees were awarded during the Convocation.

In addition to the academics the students are also encouraged to participate in sports events and extracurricular activities at the campus as well as outside the campus to enable their wholesome personality development.

The university has a newly constructed academic block with latest infrastructure and newly constructed Laxmi Bai Girls Hostel with ultra-modern facilities. The central library of the university has the stock of approximately 16000 books. It subscribes to National and International refereed journals, magazines and periodicals and also subscribes many Hindi and English newspapers. Round the clock internet facility is also available in the library premises. The university has an impressive Language Lab which is open for all the students of the university to help them to improve their communication skills. The university also has a Computer lab well equipped with the latest software and is networked with 32 mbps internet speed with fiber optical device. The Psychology lab of the university is spacious and fully equipped with latest equipment to carry out the tests. The Conference room of the university is equipped with world class facilities with a seating capacity of 40 persons. The construction for the extension of academic block, Second Computer Lab, Administrative Block, Boys Hostel, Sports Stadium and residential quarters for faculty is in full swing. The students of this university have shown commendable results in academics as well as co-curricular activities. With the present pace of progress, the university looks forward to having a promising future.

UNIVERSITY LIBRARY

Libraries are an integral part of all educational institutes in India. The library of the university is well equipped with large numbers of books. The library has subscribed many newspapers. It is planned to shift the library to its new building from the coming session i.e. 2019-20. It will be well equipped with the modern technology and infrastructure. Recently, an E-Kiosk system has also been installed for the convenience of the

students as well as faculty members. The library also provides AC reading rooms where the readers can study peacefully. The library remains open from 9.00 A.M. to 5.00 P.M. The library recorded about 500 users including students and staff of the university.

LAXMI BAI GIRLS' HOSTEL

The University has one Girls hostel named after the Queen of Jhansi, Rani Laxmi Bai. It was inaugurated by Hon'ble Governor Prof. Kaptan Singh Solanki on 12th November, 2014. It has the capacity of accommodating 240 girls. The hostel is provided with electronic gadgets including electric geysers, 32" Plasma TVs along with Dish/DTH facility and water cooler with RO system. The hostels subscribe to several national and regional dailies and magazines for enabling the students to know what is happening around the world. Sport facilities for girls include table tennis and badminton court, volley ball court, gym and different indoor games like carom-board and chess etc. Medical facilities to all hostel residents are provided through the University Health Centre located in the Hostel premises. The University also has a Horticulture Club maintained by the girls of the Hostel. Beauty and skin care clinic has been established for the grooming of the students. The hostel on the campus operates its own mess providing hygienic and nutritious meals with a varied menu. In view of the large number of students applying for hostel accommodation, the university allows hostel to the students on the basis of their merit in the admission list.

CHHATRAPATI SHIVAJI CHHATRAWAS FOR BOYS

The University has a hostel after the name of great Indian Freedom Fighter, Chhatrapati Shivaji. It was inaugurated by Hon'ble Chief Minister, Sh. Manohar Lal on 26th May, 2018. It has capacity to accommodate 200 Students. The hostel has following facilities:

1. Reading Hall Fully Air Conditioned.
2. 125 KV Generators for 24 Hrs. Power Supply.
3. Water Cooler along with RO Purifier.
4. Electric Water Geysers
5. Recreational Room equipped with 42 Inch Plasma TV alongwith D2H Connection.
6. Subscription of Several National on Regional dailies and magazines.
7. Sports facility includes Table Tennis, Badminton Court and other indoor game like Carom Board and Chess etc.
8. State of Arts Dinning Facility.
9. CCTV Surveillance.
10. Well furnished guest rooms for parents and visitors

The Hostel on the Campus operates its own mess providing hygienic and nutritious meals with a varied menu. In of the large number of students applying for hostel accommodation, the University allows hostel to the students on the basis of their merit in the admission.

UNIVERSITY HEALTH CENTRE

The Health Centre located in Laxmi Bai Girls Hostel has sufficient space for a dispensary with patient Beds and stools with drop stand. The centre has a visiting doctor and a nurse and provides medical consultation and free medicines to all students and staff. The health centre is well equipped with all basic apparatus and general medicines. The Health Centre also provides first line of treatment in emergency cases. The process for the full-fledged development of university health centre is in process and will be accomplished soon.

UNIVERSITY COMPUTER & INFORMATICS CENTRE (UCIC)

The University Computer & Informatics Centre (UCIC) is striving to develop the University as "Digital University" and working rigorously to provide the excellent infrastructure facilities with High end systems controlled by Dell Make power Server. Central UPS with a power back up of 8 hours is controlling all the Computer Systems connected via optical fiber LAN covering the whole Campus. 24*7 Internet facility with 200 Mbps is available for students as well as staff members. UCIC is continuously monitoring and updating all the information on university website. The UCIC established a Computer Centre with the objective of providing readily available facilities of computers to the students and teaching and non-teaching staff of the University. It also purports to automate administrative and secretarial wings of the University with the aim to cater to the needs of the entire University. University Computer & Informatics Centre (UCIC) is providing opportunity to enhance Professional Knowledge among students and staff members. One Language lab established to improve communication skills of the student in order to compete in the era of Globalization.

LANGUAGE LAB

The Language lab has been established to improve communication skills of the students. The Lab is equipped with latest software related to English Language and Communication. It provides a host of opportunities for students to work with online exercise sheets and virtual practice sessions, thus enabling them to learn language in a simulated environment.

PANDIT DEEN DAYAL UPADHAYAYA CENTRE

The Pandit Deen Dayal Upadhayay Centre is established in CRSU, Jind for the following objectives:

- a. **Antyodaya School:** This school is established in university campus for giving free of cost education to the deprived students.
- b. **Unnat Bharat Abhiyan:** The purpose of this abhiyan is to increase awareness to villagers regarding Govt. scheme, Water conservation, Entrepreneurship programs etc. The tree plantation and Training/Camps/Seminars is conducted time to time in villages for public awareness.
- c. **Bharat Bodh Gallery:** The main objective of this gallery is to aware students of university, colleges and schools about historical person and their achievements in life.
- d. **Human Transformation:** The objectives of this program are to encourage students to be entrepreneurs, seminars and lectures for student's awareness regarding carrier information, coaching for SSC-CGL & UGC-NET. Another objective of this program is encouraging cooperative culture amongst the students and makes them good citizens of the country.

SC/ST CELL

The SC/ST Cell has been established for the welfare of SC/ST students of the University as per the instructions of the UGC/State Government. The Cell also functions as a Grievances Redressal Cell for the grievances of the SC/ST students and employees of the University and provides them necessary help in solving their academic as well as administrative problems. The Cell also performs any other work assigned from time to time to promote higher education among the communities suffering from economic, social and educational deprivations. The main objective of the SC/ST Cell is to ensure proper implementation of various schemes of University Grants Commission/Government of India/State Government introduced from time to time.

GUIDANCE AND COUNSELLING CELL

The Guidance and Counseling Cell of university was established in 2016 with the support of Hon'ble Vice-Chancellor. The Cell meets the following objectives:

- To assist the students in Career areas (Knowledge of different career options through Career Talks)

- To help them in Personal areas (Stress, anxiety, lack of self- confidence, communication skills, Development of Positive attitude, Assertiveness Training etc.)
- To provide assistance in academic areas (study habits, Time management, Goal Orientation etc.)

Different programs under guidance and counseling cell in last year were organized in different departments. These programs were on Self Awareness, Communication Skills and enhancement of self-esteem. During these years, many students were also provided personal counseling sessions from different departments regarding their, personal, educational and career issues.

TRAINING & PLACEMENT CELL

Training and Placement Cell will invite and host companies on campus to hold recruitments for our students and in spite of the job market looking bleak this time round consists of students from different courses in their final year. The aim is to invite companies from various fields in order to make opportunities available not just for students of business but also for the students of science and arts.

Training and Placement Cell will also organize workshops and job for them. In addition, Training and Placement Cell will also organize different activities to enhance the skills of the students like:

- Soft Skills Development
- Career Building
- Mock Group Discussions
- Mock Interviews

EQUAL OPPORTUNITY CELL

The university has constituted Equal opportunity cell to provide equal opportunity to all including the persons with disability. In addition, it will also examine all the possible ways in which SC/ST, OBC and all other minority groups could be helped.

VIGILANCE CELL

The university has constituted Vigilance cell to activate vigilance machinery for investigating complaints and sensitizing the university community against corruption and corrupt practices. The main objective of this cell is to prevent the possibilities of corruption and to encourage a culture of honesty and integrity.

RESEARCH CELL

The university has constituted the Research Cell to facilitate and promote quality research in emerging areas of higher education with focus on new frontiers and to act as a knowledge power- house capable of contributing to the national development and welfare of the society.

INTERNAL QUALITY ASSURANCE CELL

The university has constituted the Internal Quality Assurance Cell (IQAC) for planning, guiding and monitoring quality enhancement activities of the University. The cell works to instill the spirit of quality consciousness and continuous improvement of academic and administrative performance of the University and to promote measures for institutional functioning towards quality enhancement through internalization of quality culture and institutionalization of best practices. In order to enhance the academic quality of the UTDs, the auditing of the departments is carried out from time to time. The university invites experts who suggest areas where the department needs to improve. All the internal audits are discussed in the meetings chaired by the Vice Chancellor, who provides directions for the implementation of the suggestions of the experts given in the audits. The IQAC is already in active mode for NAAC preparation. In this regard, a sufficient no. of workshops have been organized to make the departments aware about the importance of NAAC as well as necessary requirements for NAAC.

Internal Complaints Committee (ICC) against Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal)

The University is committed to provide to all women a place of work and study free of sexual harassment, intimidation and exploitation. It is expected that all students, faculty, staff, karamcharis and officials treat one another and visitors to the University with respect. Reports of sexual harassment are taken seriously and dealt with promptly.

Sexual harassment can take place in various forms; some subtle and indirect, some blatant and overt. For instance any one or more of the following acts of unwelcome behaviour (directly or by implication); physical contact and advances, A demand or request for sexual favours, Making sexually coloured remarks, Showing pornography, any other unwelcome physical, verbal or nonverbal conduct of sexual nature.

As per policy the University constitutes ICC every year representing different stakeholders. Students can take help of ICC without any hesitation. Complaints can be made directly to any member of ICC or through existing channels of lodging grievances, such as University Authorities, Wardens, Teachers, Students, Union/Association Representatives, and Administrative Superiors etc.

DIRECTORATE OF YOUTH WELFARE AND CULTURAL AFFAIRS

Directorate of Youth Welfare aims at ensuring the welfare of students by conceiving and organizing programmes for the establishment of a healthy cultural environment in the university. It motivates students to participate in various cultural activities to ensure their holistic development. Besides celebration of national festivals, the Directorate also organizes Talent Hunt Competitions.

SPORTS ACTIVITIES

Sports activities of the university are being run under the Sports Council. The university has the following playfields: Handball (1), Football (1), Volleyball (1), Netball (1), Korfbal (1), Kho- Kho (1), Kabaddi (1), & Athletic Track 400 mtrs. The university is going to have its Sports Stadium soon. The university provides different sports facilities to its players taking part in the inter university tournaments like free TA & DA, sport kit & track suit, free medical facility and scholarship to the players winning positions in these tournaments.

NATIONAL SERVICE SCHEME

National Service Scheme (NSS) promotes the spirit of voluntary work among the students and teachers through sustained community interactions. It brings academic institutions near to the society. It shows how to combine knowledge and action to achieve results, which are desirable for community development. NSS at Chaudhary Ranbir Singh University was established with the objective of providing the youth an opportunity to develop their overall personality by taking part in various Social Service Schemes. The University has initiated the process of students' enrolment. Students will be given opportunity to participate in state and national level camps. Merit certificates are provided to students, who perform well in the camps. The NSS unit organized special camp on digital financial literacy and four students also received appreciation from MHRD, Government of India.

BHARAT BODH GALLERY

The University has established Bharat Bodh Gallery for inculcating the values of National Pride and National Commitment, Teaching to live together for Social Harmony, Education about Bhartiya Sanskriti, Bhartiya Gyan and Gouravshali Bhartiya Itihas among students.

PHASE-III SUBSEQUENT COUNSELING FOR VACANT/LEFTOVER SEATS IN COLLEGES OF EDUCATION

If the seats after phase-I and phase -II of counselling for B.Ed. course under Govt./ Govt. Aided/ Maintained college of Education and Self- Financing Scheme Colleges of Education still remain vacant, then, next phase of counselling i.e. Phase-III for vacant/ left over seats in all the colleges will be conducted by C.R.S. University, Jind with a late fee of Rs. 1,000/- and every candidate has to apply afresh. The candidate can register online after the last date of admission of Phase-II i.e. 19-09-2019 (after appearing advertisement in news papers/ website). However, their applications will be considered in Phase-III, only if, the seats remain vacant after counselling of Phase-II. In case the need arises, the next counselling i.e. Phase-IV will be conducted with a late fee of Rs. 2,000/- and every candidate has to apply afresh again. - 1. Every College/Department shall constitute an Admission Committee to be appointed by the Principal/Chairperson from amongst the teachers of College/Department.**

Verification of the documents of the candidate will be done by the respective Admission Committee of College/Department at the time of reporting for admission, by comparing with the original certificates against which candidate has been allotted seat. Any entry or information filled/ made by the candidate, if found to be false, shall entail automatic cancellation of admission.**

Eligibility Conditions for Admission to B.Ed. Two Year Regular Course as per

NCTE Norms is as under:

Candidates with at least 50% marks either in the Bachelor's Degree and/or in the Master's Degree in Sciences/Social Sciences/Humanity, Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the programme.

- (i) There shall be no rounding off of percentage of marks of the qualifying examination from 0.5% and above to next higher number for determining the eligibility i.e. 49.5% and above will not be rounded off to 50%.
- (ii) 47.5% marks for SC/ST candidates of Haryana State only. As per letter dated :-16-07-2014
- (iii) 47.5% marks for Blind /Persons with Differently Abled and visually/Hearing Impaired candidate.
- (iv) In case a candidate has passed the Master Degree Examination also after Bachelor Degree, the higher percentage of marks obtained in either of the two will be taken into consideration while preparing the merit
- (v) Compartmental candidates will not be allowed admission in B.Ed. (Regular Course) in any case.
- (vi) Cut off date for eligibility will be the last date/time of online choice filling.
- (vii) One year PG diploma in any subject will not be considered equivalent to Master's Degree.

PREPARATION OF MERIT LIST FOR ADMISSION

Merit for admission to B.Ed. course shall be determined on the basis of marks obtained in the qualifying examination. In case a candidate has passed the Master's Degree Examination also along with Bachelor's Degree, the higher percentage of marks obtained either in Under Graduate and Post Graduate degree will be taken into consideration while determining the merit. In the event of quota reserved for Persons with Differently Abled remain unutilized due to non availability for suitable category of Persons with Differently Abled, it may be offered to the Ex-servicemen and their wards (1%) and the dependents of Freedom Fighters (1%).

Further, 3% Horizontal reservation is also provided to Ex-servicemen/Freedom Fighters and their dependents by providing reservation within reservation of 1% of general category, 1% out of Scheduled Castes and 1% from backward classes' category for admissions to the various educational institutions of the Government and Government aided/institutes Located in Haryana. As far as block allocation in Block A and Block B of Backward Classes Impairment/Persons suffering from Locomotor Disability or Cerebral Palsy should be indicated clearly. For example, if Block A of Backward Classes are given seats in the Academic year 2014, the next Block i.e. B Block of category of Backward Classes will be given seats in the next academic year i.e. 2015 and so on. The Head of the Department concerned shall maintain the record for the purpose.

Note: A roaster for reservation of Ex-Serviceman/Freedom Fighter be maintained and carry forward all fractions till one seat is accumulated through different fractions over the years. As and when the total comes one, a seat will be provided in the prospectus. (Chief Secretary to Govt. Haryana Letter No. 23/27/2004-2 GS III dated 5.12.2008 Annexure-XIX).

Admission Criteria for EWSs derived from the Government of Haryana, Notification No. 22/12/2019-1GS-III dated 25.02.2019 and even No. dated 13.03.2019 as under:

(a) Income & Assets Certificate issuing Authority:

- (i) The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Competent Authority for EWS Income and Asset Certificate shall be Tehsildar of the area where the applicant normally resides.
- (ii) As per instructions given in Govt. of Haryana General Administration Dept. (G-III Branch) Notification No.22/12/2019-1GS-III dated 13.03.2019, Verifying Authorities for issue of EWS

Certificate shall be same as prescribed for issue of resident/income certificates as specified in instruction No. 22/28/2003-3GS-III, dated 30.01.2004.

(iii) The prescribed format for EWS Income and Asset Certificate shall be provided at **Annexure-XVIII.**

(b) Criteria of Income & Assets:

- (i) Persons who are not covered under the existing scheme of reservation for Scheduled Caste, Backward Classes (Block-A) and Backward Classes (Block-B) and whose family has gross annual income below Rs.6.00 lakh (Rupees six lakh only) are to be identified as EWSs for benefit of reservation, Income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application.
- (ii) Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-
 - a) 5 acres of agricultural land and above;
 - b) Residential flat of 1000 sq. ft. and above;
 - c) Residential plot of 100 sq. yards and above in notified municipalities;
 - d) Residential plot of 200 sq. yards and above in areas other than the notified municipalities;
 - e) Total immovable assets owned are valued at Rs. One Crore of more.
- (iii) The property held by a “Family” in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- (iv) The term “Family” for this purpose will include the person who applies for benefit of reservation, his/her parents, spouse as well as children and siblings below the age of 18 years.

Note : For any other clarification, Government of Haryana, Notification No. 22/12/2019-1GS-III dated 25.02.2019 and even No. dated 13.03.2019 will be referred.

Subject: Regarding prescribing minimum eligibility qualification for the various courses.

Sir/Madam,

I am directed to invite your kind attention towards Government instructions No. 3870-WGI-ASOII-64/20069 dated 6th/19th October, 1964 whereby the candidates of Scheduled Castes and Scheduled Tribes provided 5% reduction in marks in the minimum eligibility qualification for admissions in various courses.

It has come to the notice of the Government that at present where a General Category candidate is required to have 50% marks in a prescribed qualification for admission in any course, as per the above instructions a reserve category candidate is required to have 45% marks giving him 5% reduction in the minimum qualification. Vide judgment of Hon'ble Supreme Court in Civil Appeal No. 7084/2011, it has been observed that the practice is wrong and the relaxation of 5% should be reduced from the minimum required marks on a general category candidate for e.g. :-

In a course, a general candidate requires to have 50% marks, than as per Govt. instructions by giving 5% relaxation the minimum eligibility marks for a reserved caste candidate should be calculated as under :-

Out of 100 Marks needs to less = 5

Out of 1 Marks needs to less = 5 / 100

Out of 50 Marks needs to less = 5 / 100 X 50 = 2.50

This way minimum less marks where general category candidates are required to have 50% in a prescribed qualification, the total required marks for a reserved candidates will be 50 - 2.50 = 47.50 and not 45.

All concerned are requested to implement the instructions as per the above procedure in the compliance of the judgment of Hon'ble Supreme Court passed in CWP No. 7084/2011.

GUIDELINES FOR RESERVATION

1. The Reservation of seats is as per the Reservation Policy of the Haryana Govt. and is subject to any change/amendment made by the State Govt. from time to time.
2. All the eligible candidates whether from Haryana or from Reserved Categories shall also compete for seats allocated under All India Category.
3. All eligible candidates of reserved categories shall be considered first for Haryana Open Category seats.
4. If a candidate of Haryana Open, SC and BC category also apply for Persons with Differently Abled/ESM/DFE category will be considered first for Haryana Open, SC and BC category
5. If the reserved seat(s) of BC Block-A remain vacant, these will be filled up from BC Block-B and vice-versa.
6. Benefit of reservation will be given to all the reserved categories upto Final List according to the reservation policy given in the Prospectus. In case at the time of display of Final List the reserved seats of various categories other than S.C. category, remain vacant and no eligible candidates of the reserved categories are available, these vacant seats will be filled up on open merit basis at the time of Final List. The vacant seats of SC category will not be converted.
7. Candidates claiming reservation under Scheduled Caste will submit the certificate as per Annexure-V, the Backward Class (Block A & B) will submit the certificate on the prescribed proforma as per Annexure-VI and an affidavit shall be furnished by the candidate/both by the father and mother of the candidate as per Annexure VII, that he/she is not covered under the criteria of Creamy Layer.
8. Only those candidates having a permanent disability of not less than 40% (being otherwise fit for admission to the course) will be considered for admission. Persons with Disabilities will have to produce the Disability Certificate issued by the Chief Medical Officer of the concerned District. However, the certificate shall be subject to verification by a Medical Board constituted by the university for the purpose. The decision of the Board shall be final. Persons with Disabilities candidates belonging to Haryana are required to submit the certificate as per Annexure-VIII. However, Medical Certificate already issued by the Competent Authority will also be considered.
9. Children & Grand-Children of Freedom Fighters of Haryana are required to submit a certificate from the Deputy Commissioner of the concerned District as per Annexure-IX at the time of admission.
10. Wards of Ex-Servicemen of Haryana are required to submit the certificate as per Annexure-X.
11. For the horizontal reservation, candidates of Haryana Open, S.C. and B.C. categories will also have to furnish E.S.M. /D.F.F. certificate.
12. Candidates who have passed their qualifying examination from a University in the State of Haryana will be deemed to be Haryana residents and will not be required to submit certificate of Bonafide residents of Haryana.
13. **Reservation policy is not applicable on Private Educational Institutions (SELF FINANCING SCHEME Colleges) which receive no aid from the State irrespective of the mode of Examination i.e. either by themselves or by Nodal Authority vide Memo No. 18/170-07 UNP(4) dated 27.8.2007 from Commissioner and Secretary to Government Haryana, Education Department, Chandigarh.**
14. A person belonging to the General Category married to a person belonging to the Scheduled Caste or Backward Classes, he/ she shall not be entitled to the benefit of reservation vide. Letter No. 22/57/2007-3GS-III dated 6/9/2007 from the Chief Secretary to Govt., Haryana.

ONLINE ADMISSION PROCEDURE

This section provides an overview of the steps involved in counselling and admission process.

A. Online Registration

- Candidate should visit website www.crsu.ac.in, <http://hrybed.in/> <http://hrybed.net/>
- Candidates should go through prospectus for gathering information/instruction in details about counselling schedules and procedures. Softcopy is available on the websites www.crsu.ac.in, <http://hrybed.in/> <http://hrybed.net/>
- For phase-I and phase-II candidates will register themselves as per key dates mentioned in the admission schedule for Govt/ Govt Aided/ University Maintained/Self-Financing Colleges of Education in Haryana.
- For participation in online admission process, a candidate has to register by submitting personal data/requisite information correctly in the online application form. On submitting this data/information user Id and password will be generated/ created for use in future logins by the candidate.
- For subsequent logins, candidates will be able to login directly with their user Id and password. Candidates should remember to logout at the end of their session so that the details filled by them cannot be tampered with or modified by unauthorized person.
- Candidates are advised to record/remember their password for future logins and not to disclose or share their password with anybody.
- It is solely the responsibility of the candidates to verify that their personal data including Category, Subcategory, Group (Science/ Arts with Maths & Art/Commerce), Residential Status, gender etc are consistent with documentary evidence.
- If the personal data submitted /entered by the candidates are found to be wrong at the time verification of certificate either during reporting or at a later stage, the allotment of seat/ provisional admission is liable to be cancelled.
- Candidates should take a print out (hard copy) of the online application form containing the above personal data for future use.

B. Payment of Registration & Counseling Fee.

- For depositing of registration and counseling fee of Rs. 1000/- for General Candidate and Rs. 625/- for SC/BC/PH, and Girls candidates of Haryana State (non-refundable), visit website www.crsu.ac.in and click on 'Payment' and generate E-slip of bank of your choice for cash payment or select any other mode of payment available on above website for the deposition of registration and counseling fee. Fee can also be deposited in the above banks through Credit/Debit cards and Net Banking on the charges already fixed by the concerned banks

- For fee paid in cash in the bank the payment status of the candidate will be updated on the website with in 48 hours of fee deposition in bank. Candidate can fill his/ her choices after updation of fee payment status.
- Last date for payment of Registration-cum-counseling fee for Phase-I, (for Govt/ Govt Aided/

University Maintained Colleges of Education) and Phase-II (for B.Ed. course under SELF FINANCING SCHEME colleges only) is as per key dates mentioned in the admission schedule.

- Remember you have paid your registration-cum-counseling fee before proceeding for online counseling, otherwise your allotted seat can be CANCELLED at any stage and candidate would not have any claim on such allotted seat.

C. Online Choice Filling & Locking

- For phase-I and phase-II online choice filling & locking by the candidate can be done as per key dates mentioned in the admission schedule for Govt/ GovtAided/ University Maintained /Self-Financing Colleges of Education in Haryana.
- If the fee is paid by a candidate through internet banking/credit card/debit card, then the choice filling open will be activated immediately otherwise the candidate has to wait for next day to get the option activated.
- Candidates are advised to go through the updated list of Colleges of Education in Haryana on the website www.crsu.ac.in and should prepare a list of Colleges in order of preference in which they are interested in seeking admission.
- Candidates can fill in as much number of choices in order of preference as they wish to. Candidates are allowed to change or re-order their choices, delete earlier choices and add new choices any number of times until they lock their final choices.
- All the candidates must lock their final choices as per key dates mentioned in the admission schedule.
- Candidates will not be able to unlock their choices once they are locked.
- If candidate fail to explicitly lock their choices by the last date, their last saved choices will be automatically locked and allotment will be done on this basis.
- Candidate must take a print out of their locked choices. This print out has to be signed and submitted at the time of reporting for admission.
- Registered candidates who do not fill choices or fail to save the same cannot be considered for admission and seat allotment.

D. Indicative seat Availability (Mock Counseling)

Based on the number of registered candidates who have submitted their choices before the key dates mentioned in the admission schedule, the system will be able to provide an idea of the seats that candidates may be offered in phase-I for Govt/ GovtAided/ University Maintained Colleges of Education and for phase-II for B.Ed. course in Self Financing Scheme Colleges only. The indicative seat availability will be displayed on the websites www.crsu.ac.in as per key dates mentioned in the admission schedule. Candidates are advised to visit the websites www.crsu.ac.in for this purpose. The final allotment of seat, in the allotment rounds may be different than the indicative seat availability.

E. Online Seat Allotment

First Round

- Seats will be allotted in the order of merit and preference/ choices as per admission schedule as mentioned in different phases.

The allotment result will be available on the websites www.crsu.ac.in Individual allotment letters will not be sent to the candidates. However,

candidates may get a print out of the allotment details from the above websites.

- Candidates who are allotted seats will have to personally report to the allotted college.

Second Counseling

- Seat will be allotted against vacant seats available after the first round of allotment and reporting.
- Registered candidates will not be allowed to alter or resubmit their choices.
- Eligible candidates for allotment against vacant seats fall into one of the following two groups:
Group-I: Candidates who reported at the allotted college after first round of seat allotment and opted for all the choices of preference higher than the currently allotted seat (auto upgradation) to be considered in the subsequent round(s).
Group-II: Registered candidates who were not allotted any seats in the first round of seat allotment.
- Candidates who, at any stage, cancel their provisional admission will not be considered for the subsequent round(s) of counseling. Also, if candidates fail to satisfy the minimum educational qualifications prescribed, their allotment of the seat shall automatically stand cancelled and such candidates will not be considered for the subsequent round(s) of counseling.
Candidates opting for auto upgradation shall automatically forego his/ her claim on the seat previously allotted
Similar procedure will be used in the subsequent round(s) of the seat allotment.

F Reporting at Allotted College/Institute

- The outcome of the different rounds of seat allotment will be displayed on the websites www.crsu.ac.in, [http://hrybed.in/](http://hrybed.in) <http://hrybed.net/>

(as per admission schedule). Individual allotment

letters will not be sent to the candidates by the university.

- All the candidates who get an allotment should take print out of this provisional seat allotment and will report to the allotted College/Institute as per specified reporting dates for taking admission, failing which their seat allotment shall stand cancelled. Also, they will not be considered for further rounds of seat allotment.
- Candidates will produce all the relevant certificates in original including registration and counselling fee receipt for verification alongwith provisional allotment letter, a signed print out of their online application form, their locked choices generated from the website at the time of reporting.
- At the time of reporting if documents are found correct on verification and the fee is paid (as mentioned in the prospectus) by the candidate, then a provisional admission letter generated online will be issued to the candidate by the concerned college. The candidate shall check all the entries in this provisional admission letter and should sign it and preserve it for further reference.
- At the time of reporting if documents are found correct on verification and candidate opt for auto upgradation, then a provisional auto up-gradation letter generated online will be issued to the candidate by the concerned college. The candidate shall check all the entries in this provisional auto up-gradation letter and should sign it and preserve it for further reference.
- The allotment of their seats is liable to be cancelled, if the personal data viz. Category, Sub-category, Group (Group-I Science & Arts with Maths Group-II Arts & Commerce) residential status (Bonafide Residents of Haryana or All India Category), percentage of marks in qualifying examination, gender etc. submitted by the candidates at the time of registration is found to be

wrong at time of verification of the original certificates at allotted Institutes, But, if the candidate is found to be eligible after the correction in personal data, the candidate may be considered for subsequent rounds of counseling, if any, against the vacancies only.

- If a candidate is admitted on the basis of the information submitted by him/ her, which is found to be incorrect or false at any stage then his/ her admission shall be cancelled and all fees and other dues paid by him/ her shall be forfeited. The University/ College/ Institute may take further action, as deemed fit, against the candidate in accordance with law.
- The allotment of the seats to candidates who do not report within the stipulated period to the allotted college will be cancelled and these candidates will not be considered in the seats allotment in the subsequent rounds

List of documents to be brought at the time of reporting in the institute:

The candidates, at the time of reporting must bring the following Original Certificates/ Documents/ Testimonials along with two sets of duly attested photocopies of these with them. Any candidate, who fails to produce any of the required Certificate/ Document/ Testimonial at the time of reporting the institution, will forfeit his/her claim to admission.

- (i) Qualifying Examination i.e. Bachelor Degree and /or Master's Degree or Shastri Degree 3-year (with or without English)/ Acharya Degree two year. The candidate will bring the DMCs of all the years of Bachelor and Master Degree or Shastri/Acharya Degree.

- (iii) 10+2/Intermediate/Senior Secondary School Examination Certificate & Detailed Marks Card.
- (iv) Character Certificate:
- (a) **Regular Candidates:** The candidates who have passed their qualifying exam from College/ Department as regular students are required to submit the Character Certificate as per Annexure-XIV.
- (b) **Private Candidates:** Male candidates, who have passed the qualifying examination as private candidates should submit their Character Certificate, duly signed by a Notary Public.
- (c) **Gaps in study:** Male candidate who have gaps in their academic career after the qualifying exam., must furnish a gap certificate, in the form of affidavit on non-judicial stamp paper or certificate from the employer (if in the service) and should also furnish separately the character certificate of gap period duly attested by Notary Public.
- (v) Residents Certificate as per Annexure-XI, if applicable: Candidates, who have passed their qualifying examination from a university located in the State of Haryana will be deemed to be Haryana residents and will not be required to submit certificates of bonafide residents of Haryana.
- (vi) Certificate from the Employer in the case of Employees of Govt. of Haryana, members of All India Services borne on Haryana Cadre, Employees of Statutory Bodies/Corporations as per Annexure-XII, if applicable.
- (vii) Scheduled Caste Certificate as per Annexure-V, if applicable.
- (viii) Backward Class Certificate as per Annexure-VI, if applicable and affidavit as per Annexure-VII.
- (ix) Special backward Classes certificate as per Annexure-VI-A.
- (x) Economically Backward Persons in General Category Certificate as per Annexure-VI-B.
- (xi) Certificate in respect of Persons with Disabilities Candidates as per Annexure-VIII, if applicable.

- (xii) Certificate required to be furnished by the Children & Grand-children of Freedom Fighters as per Annexure-IX, if applicable.
- (xiii) Certificate from Ex-Servicemen of Indian Deference Services or Para-Military Forces-Annexure-X.
- (xiv) Provisional Allotment Letter
- (xv) Original Receipt of Registration & Counseling Fee.
- (xvi) Print out of Online Application form along with their locked Choice.

Note:

- (i) All Original documents, 04 latest passport size photographs and 02 sets of attested photo-copies of all applicable documents/testimonials/certificates must be brought at the time of reporting.
- (ii) The original certificates shall be returned back after verification by the College/institute.
- (iii) 2 sets of attested copies of certificates/documents/testimonials will be verified & signed by the Principal or his authorized representative & will be retained for registration purposes in the University.
- (iv) If the original certificates are not in Hindi/English, duly certified Hindi/English version/translation of such certificates will be required.

ANNEXURE-I

Instructions regarding Bonafide Residents of Haryana issued vide letter No.62/17/95-6 GSI dated 3rd October, 1996, No.62/32/2000-6GSI dated 23rd May, 2003, No.62/27/2003-6GSI dated 29th July, 2003 and No.62/62/2011-6GSI dated 17th January, 2012 by the Chief Secretary to Government, Haryana.

Subject: Bonafide residents of Haryana - Guidelines regarding.

1. I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subject noted above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institution (including technical/medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and others reported as AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate:-
 - (I) Candidates, who have passed the examination qualifying there for selection in an institution from a school/college in Haryana.
 - (II) Children/Wards (if parents are not living)/Dependents: -
 - (i) of the regular employees of Haryana State posted in or outside Haryana State or working on deputation;
 - (ii) of the regular employees of the statutory bodies/corporations established by or under an act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana.
 - (iii) of the regular employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government;
 - (III) Children/wards (if parents not living)/dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.
 - (IV) Children/wards (if parents are not living)/dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a state other than Haryana or he has settled after retirement in or outside Haryana,
 - (V) Children/Wards (if parents are not living)/dependents of persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana;
 - (VI) The wives of such persons who are bonafide residents of Haryana irrespective of the fact that they had belonged to any other State before marriage;
 - (VII) Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/guardians (if parents are not living) of persons belonging to any one of the above mentioned categories are :
 - (i) Citizen of India;
 - (b) Produce an affidavit to the effect that they or their children/wards (if parents are not living)/

dependents have not obtained the benefit of Resident in any other State.

(VIII) Children & Wards of the accredited journalists residing at Chandigarh and recognized by Govt. of Haryana.

2. All candidates claiming to be bonafide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/General Assistant to Deputy Commissioner or Sub-Divisional Officer (Civil) of the District/Sub-Divisions/Tehsildars of Revenue to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/Wards/Dependents of Haryana Govt. employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children/Wards/Dependents of pensioners of Haryana Govt. or in respect of the Children/Wards/Department of the employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/Wards/Dependents of the employees and retirees of the Statutory Bodies/Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana or outside Haryana, should be by their respective Heads of Departments.
3. Candidates seeking admission in educational institutions (including medical and technical institutions) located in Haryana may not be required to produce Resident Certificate, if they have passed the examination from a school/college situated in Haryana. For this purpose, a certificate of the Principal/Headmaster from concerned institution where the children/wards studied last should be considered sufficient. The Principal/Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.
4. If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim was false, the student shall be removed from the institution, all fees and other dues paid up to the date of such removal shall be confiscated. The Principal/Headmaster may take such other action against the student and his/her parents/guardians as he may deem proper in the circumstances of any particular case.
5. The children/wards/dependents of the employees of Punjab & Haryana High Court, who are discharging their duties in connection with the affairs of the State of Haryana and have not availed facility from their parent State, the State of Punjab and U.T. Administration Chandigarh, would also be eligible for grant of Resident Certificate of the State of Haryana only for the purpose of admission in academic/technical/medical institutions of the State of Haryana. However, in that case the employees of the Punjab & Haryana High Court shall be entitled to draw this benefit at one place/State only. Head of the Department of the Punjab & Haryana High Court would be competent to issue such a certificate.

No. 808-SW(1) - In exercise of the powers conferred by clause (d) of Section 2 of the Haryana Backward Classes (Reservation in Services and Admission in Educational Institutions) Act, 2016 (15 of 2016), the Governor of Haryana hereby specify the following criteria for exclusion of creamy layer within the Backward Classes as per the Schedules appended to the Act, namely Schedule I, II & III :-

The children of persons having gross annual income of upto Three Lakh rupees shall first of all get the benefit of reservation in services and admission in educational institutions. The left out quota shall go to that class of Backward Classes of citizens who earn more than Three Lakh rupees but upto Six Lakh rupees per annum. The sections of the Backward Classes earning above Six Lakh rupees per annum shall be considered as Creamy Layer under section 5 of the said Act.

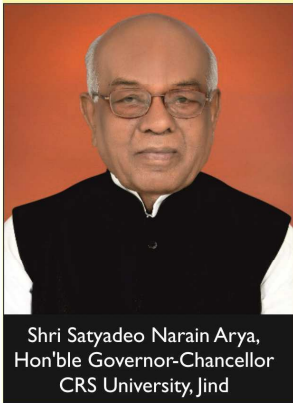

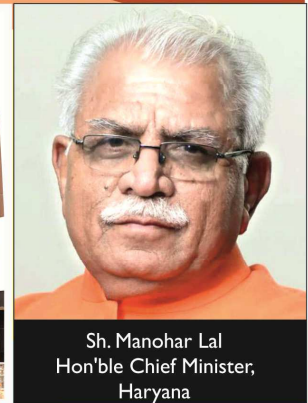

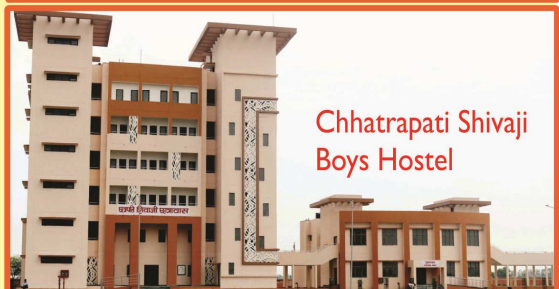
